Location

Lanark is a busy market town lying approximately 20 miles south east of Glasgow and 30 miles south west of Edinburgh. The town has a resident population of circa 10,000 persons with a catchment in excess of 55,000 persons.

The property occupies a prime position on the north side of the High Street, with nearby retailers being a mix of multiple and local traders to include Greggs, Boots the Chemist, Costa Coffee and Ebi's Fish & Chips.

Description

The property is a self-contained retail unit offering accommodation over ground, first and attic floors. The unit benefits from extensive display frontage and central entrance doors.

Internally the subjects provide sales accommodation at ground floor with partial sales at first floor. To the rear the unit benefits from direct loading access from a common carpark.

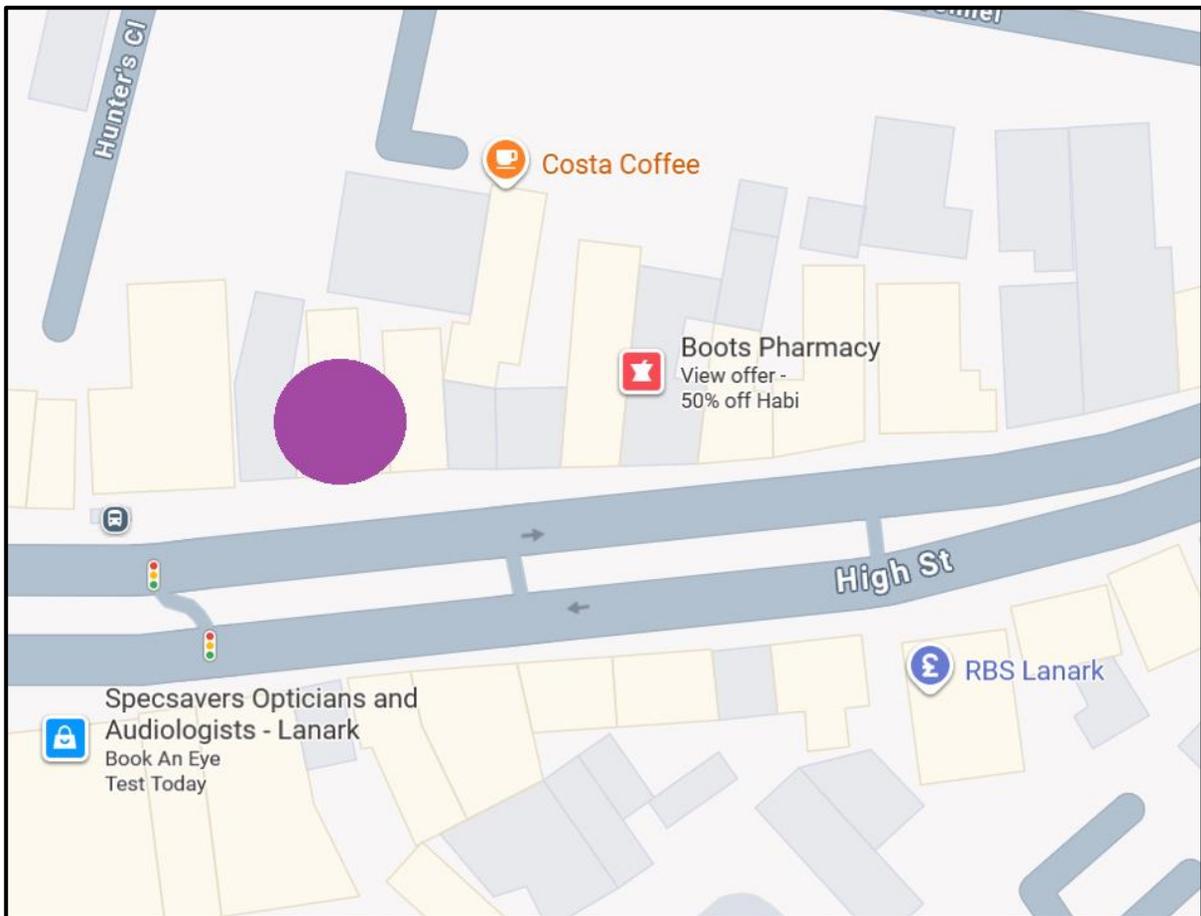
